3. Registration Form along with payment must be submitted in shape of Bank Draft/Pay Order/Online in the name of Humara Ghar Pakistan.
4. Branches of Bank Alfalah Ltd, Bank Al Habib, Dubai Islamic Bank, Habib Bank Ltd, MCB Bank Ltd, Standard Chartered Bank and United Bank Ltd will accept the Registration Form alongwith Pay Order / Demand Draft.
5. Each Registration Form is for one Residential plot only. One person can apply for one plot in each size category only.
6. After submission of Registration Form, the registration will remain non-transferable.
7. Allotment of Plot will be through computerized balloting. Deposited amount, except the processing fee, will be refunded to the unsuccessful applicants after 90 days of the ballot.
